WHAT IS THIS PRODUCT?

PURPOSE

The investment objective of the product is to seek to outperform the following indicative composite indicator over the recommended investment period through active profiled management: 10% euro-hedged MSCI World closing (net dividends reinvested), 40% Bloomberg Euro Aggregate closing (coupons reinvested), 50% capitalised €STR.

The product is a French UCITS fund.

The product's portfolio is composed mainly of equities and fixed-income instruments from all geographical areas.

The product's sensitivity range is between 0 and 8.

Between 80% and 100% of the product's net assets are exposed to interest rate risk.

It may invest up to 100% of its net assets in units or shares of French or foreign UCIs.

The use of derivatives and securities with embedded derivatives for hedging and/or exposure purposes is permitted for up to 100% of the net assets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator:
